

## **Toward decarbonization of society**

Reduce emissions in our own value chain through a variety of initiatives	Decarbonization of society through offering products and services
Evaluate emissions by Scopes 1, 2 & 3 Widely used as de facto standard	There is no tool to assess corporate social contributions Concept of "Avoided Emissions" is real, but no unified standards and low awareness in business society

## International standardization of "Avoided Emissions"




Guidance to be issued on "Avoided Emissions" for all sectors – Another pillar of the concept complementing reductions in emissions based on Scopes 1-3



Working to globally standardize definition & calculation methods of "Avoided Emissions" to raise social awareness of mitigation contributions (=social contributions) through business activities

Progress being made toward completion in 2024

### **Avoided Emissions**

Difference in size of emissions between existing electric/electronics products/systems (defined as baseline) and newly developed energy-efficient products

Or the size of emissions to be avoided through use of services with new digital technologies, e.g., AI, IoT & Digital Twin

## Create opportunities for decarbonization of society

# Build cross-sector consensus on unified measurement method for corporate decarbonization efforts

Disseminate concept of "Avoided Emissions" based on transparent and fair guidelines on measuring the value of corporate activities in a cross-sector manner, including the financial industry

#### Accomplish global standardization & clarification of implementation rules

Promote global standardization in each industry, as is the case with IEC, to help relevant organizations and industries set specific implementation rules

#### Promote use of products/systems/services that achieve "Avoided Emissions"

By collaborating with companies with the same aspirations, we will more quickly gain the support of capital markets for decarbonization efforts and thus improve Enterprise Value
