Overall Objective

Reporting is a core component of the GBP and SBP. Issuers are required to report on the use of proceeds by providing a list of the projects to which Green/Social/Sustainability Bond proceeds have been allocated and a brief description of the projects and their expected impact. The objective of the IRWG is to continue to develop guidance that supports the reporting process and facilitates the interpretation of reporting data.

Objectives for 2023-2024

- Explore the existing carbon footprint methodologies, including PCAF, and potential effect and application of evolving standards and definitions of carbon footprints, based on absolute annual project emission, and on impact reporting, given its current inclusion in "Other indicators" of the Handbook Harmonised framework for-impact reporting.
- Explore practical guidance around material risks and/or potential negative or positive impacts of
 projects. This can touch upon a broad array of aspects to be determined in the work cycle
 (potentially further guidance around "just transition" relevant transparency as well as supply
 chain or procurement related aspects).
- Mainly in a social context, explore additional practical guidance on how to e.g. organise, apply and aggregate the most frequent metrics (also highlighting transparency around potential restrictions / limitations).
- Engage with other Working Groups or external initiatives to provide and coordinate feedback on impact reporting relevant topics (such as liaising with the SLB WG regarding further development of green and social KPIs).

Deliverables

Further development of existing guidance documents or new documents, as appropriate, for the above topics.

Membership

The working group is open to all Members & Observers (including NGOs, rating agencies, technical advisors or consultants).

Active contributors should be limited **to 4-6** organisations per workstream with relevant knowledge / experience in the topics described in the objectives.
